STEP 3

A product of equal or greater value will be sent to you in a timely manner.

Exclusions & Limitations

This limited warranty is the exclusive warranty applicable to Rubix Battery products. Rubix Battery expressly disclaims any other expressed or implied warranties of Rubix Battery products, including, but not limited to, any implied warranties of merchantability or fitness for a particular purpose. No warranties whether express or implied, including but not limited to, any implied warranties of merchantability or fitness for a particular purpose shall apply after the limited warranty period.

Rubix Battery also expressly limits its liability in the event of a product defect to repair or replace in accordance with the terms of this limited warranty, and exclude all liability for incidental or consequential damages, including without limitation any liability for the Rubix Battery product not being available for use or lost revenues or profits, even if Rubix Battery has been advised of the potential for such damages. Some states (or jurisdictions) may not allow the exclusion or limitation of certain warranties or damages, so some of the above exclusions may not apply to you.

If there is any inconsistency between this Limited Warranty and any other agreement or statement included with or relating to Rubix Battery products or services, this Limited Warranty shall govern.
